The appointment as TTA on compassionate ground appointment, should possess the minimum education qualification of 3 years Engineering Diploma in Telecommunications Engineering/ Electronics Engineering / Radio Engineering / Computer Engineering / Instrument Technology or its equivalent from any Technical institute recognized by the Central Government after 10 standard as provided in Recruitment Rules.
4. Further necessary action may kindly be taken at your end to appoint the candidate(s) after observing all due departmental and recruitment formalities. The pre-recruitment formalities in respect of the TTA may be done as per instruction contained in this office letter no. RE/12-03/DR TTA/2012/76 Dated 04.01.2014.
5. The date of appointment of the candidate as Group 'C' may be intimated to this office as soon as he/she is actually appointed.
6. In the Annexure-I date of death/retirement on medical ground/missing of employee is given. However the said date must be checked & verified from your office record, before issuing appointment order.
7. If any candidate refuses to accept the offer of Group 'C'- Telecom Technical Assistant post, a refusal may be obtained and copy of the same duly attested by Head of SSA may be forwarded to this office immediately.



All the relevant formalities for the pre-recruitment of the candidates may please be completed latest by 23.10.2015 positively. **A comprehensive report accordingly may please be sent to this office latest by 31.10.2015 so that they may be sent for induction training as prescribed in the recruitment rules.**
10. If in any case candidate has expressed his/her inability to accept CGA and in his/her place any other family member is willing to apply for CGA, a fresh application may be obtained from the candidate and shall be treated as a fresh case.
