**Circular R&C-CFA No. 94/16-17**

**Subject: Clarification regarding availability of add-on voice packs on FTTH Broadband plans for offering 24 Hrs. Unlimited free calls (Local + STD) to any network under Broadband combo plans in selected SSAs -reg.**

1. The competent authority has decided ***to issue the following clarification to the concerned circles where add-on voice packs (Rs. 48/- pack for unlimited calling within circle and Rs. 98/- pack for unlimited calling in India) under Broadband combo plans in selected SSAs are available:***

***“Add-on voice packs (Rs. 48/- pack for unlimited calling within circle and Rs. 98/- pack for unlimited calling in India) introduced under Broadband combo plans with plan FMC Rs. 700/- & above in selected SSAs of Rajasthan, Haryana, MP, AP & Gujarat Circles, are also available for FTTH Broadband combo plans with plan FMC Rs. 700/- & above and as per the terms & conditions mentioned in the earlier circulars.”***

2. The Circles shall ensure to comply with all regulatory mechanism and also **update the circle website.**
3. These instructions shall ***be effective with immediate effect in concerned SSAs of above circles only.***
4. ***All other terms and conditions shall remain same as per earlier circulars.***
