Subject:- 7th meeting of BSNL Staff Welfare Board – decision taken

The following decisions have been taken by the BSNL Staff welfare Board in its meeting held on 28th August, 2008:-

- Increase in rates of Scholarship** : It has been decided that the rate of scholarship be increased by 20% for all categories. The details of the same are given below:-

4	Non-technical courses – BA/B.Sc/B.Com	Rs. 150/- per month	Rs. 180/- per month
5	All ITI courses in ITIs	Rs. 150/- per month	Rs. 180/- per month
6	Handicapped children studying in Colleges	Rs. 200/- per month	Rs. 240/- per month

2. **New Degree courses** : It has been decided to include Hospital Management/BBA/Aircraft Maintenance Engineering course(3 years courses) along with the course at Sl.No.2 above for award of scholarship @ Rs. 360/- p.m.
3. **Enhancement of Financial Assistance in case of death :-** It has been decided that the immediate financial assistance in case of death of an employee be increased to Rs. 15,000/- from the existing limit of Rs. 10,000/-. It has also been decided that this amount may be allocated as impressed to one Officer in every unit so that it can be disbursed immediately to the family of deceased employee.
4. It has been decided that all the information and circulars about the welfare programmes should be placed on the **Circle website**.
5. It has been decided that in the Circle/SSA website, the list of staff grievance Officers and the members of sexual harassment Committee of each Circle/SSA/field units should be displayed.
6. **Internet Kiosks:-** It has been decided to install free **Internet Kiosks** in main BSNL Offices /exchanges where concentration of staff is there for the use of our employees so that they can obtain latest information about BSNL and its activities.

These orders will come into force **with immediate effect**.
