
Kindly confirm whether your SSA is regularly holding DPC/CPC for NEPP of SSA cadre staff every six months.

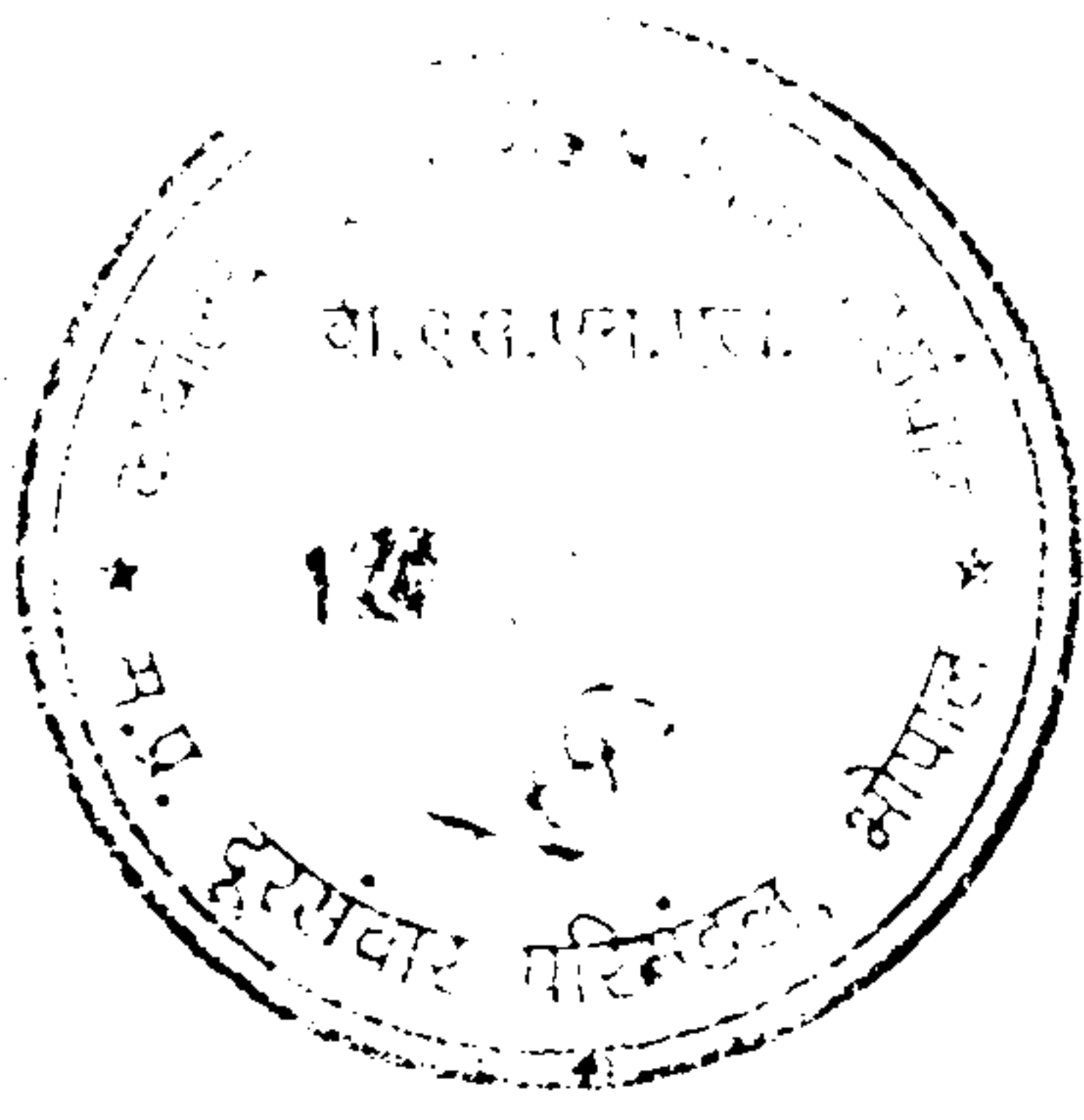


Kindly get the matter investigated and remedial action taken so that the employees may get their due claims.
